## What information we collect from you

- When you sign up to become a member of Westfield iQ via our online registration, we will collect your personal information, including but not limited to your name, email address, postcode, suburb and demographic information. Demographic information includes data such as age, gender, household status, work status, income ranges or other preference information.
- Information you provide through surveys (including any personal information)
- Information you provide in interactive areas on Westfield iQ, such as open forum discussions and bulletin boards, where you may post comments.
- Anything you post in these areas will become available to other members of Westfield iQ, so you should exercise caution.

# We want to make your Westfield experience the best experience it can be, and we use the information you provide through Westfield iQ to help us to do this.

We will use your personal information and the other information you provide on Westfield iQ for the following purposes:

- to inform what improvements we can make to the experience you have with Scentre Group including, but not limited to, our website, parking experience, centre operations and design, retailer offerings, marketing communications that we produce, in centre events and other aspects of the customer experience.
- to understand how different groups of community members interact with our living centres, and how these interactions may change over time.
- we will use the contact details you provide on Westfield iQ to communicate and provide you
  with information directly related to Westfield iQ (this could include providing you with news or
  updates in line with your preferences).
- for registration in any contests and promotions directly related to Westfield iQ (e.g. we will use your information to include you in these draws and inform you if you are a winner).

If you no longer wish to participate in the Westfield iQ community, or no longer want to receive emails, notifications or newsletter updates you can opt out at any time by following the links on the emails you receive or by managing your preferences through your 'my account' page in Westfield iQ. ### **Sharing information**

Westfield iQ will not share your personal information with third parties except as set out in this statement.

We may use, disclose or match your personal information with:

- your consent;
- other data stored internally within Scentre Group, e.g. if applicable, ticketless parking data, wifi
  data and email subscription data. This is for the purposes of improving the accuracy of our
  results by combining your survey answers with other data in order to tailor the experience,
  products and services that we offer to best suit our customer's needs.
- our trusted suppliers in Australia who we have chosen to provide services to us in connection with the Westfield iQ platform. Your data can only be accessed and used by these suppliers for the primary purpose for which it was shared, or for other purposes to which you, expressly or impliedly, consent.
- where permitted or required by law.

We will ask for your consent again if we propose to use your personal information for any other purpose.

### How we store your information

- All Personal Information that you provide through Westfield iQ will be encrypted when in transit and at rest, and stored securely on servers in Australia.
- We will delete your personal information if your Westfield iQ account is inactive for a period of 12 months. Otherwise, we will continue to store your personal information until the Westfield iQ community closes or you opt out from Westfield iQ.

Please note that it may take up to 48 hours to reflect your opt out request.
